G20 Goods Trade Dip in Q2

Steepest Since 2009 Crisis'
NEW DELHI The decline in goods trade in the second quarter of the year in the G20 countries was the steepest since the financial crisis of 2008, the Organisation for Economic Co-operation and Development (OECD) said on Tuesday. The Paris-based organisation also said recent data point to a continued improvement in the trade scenario. While China was the G20 economy to record export growth in the quarter, it said India and Indonesia experienced "particularly sharp falls in exports". The 19 measures introduced in most countries to prevent G20 merchandise trade plummeting in the second quarter of 2020, it said.

India Insurance Coverage

Below Global Average
NEW DELHI India's insurance penetration, at 3.76% of gross domestic product (GDP), was well below the global average of around 10%, according to Subhash Khuntia, chairman of Insurance Regulatory and Development Authority of India (IRDAI). "The total premium we collect is only 3.76% of GDP. The world average insurance penetration is a little higher at 7%," Khuntia said, during a conference organised by the Federation of Indian Chambers of Commerce and Industry on Thursday. To improve this figure, Khuntia urged insurers to design micro insurance products to cater to rural and tier two, three and four cities, anticipating demand as Covid spreads through the country.

Railway Min Looks to Rope

Leading Solar Developers
NEW DELHI The railway ministry is looking to rope in leading solar power developers in the country including Renew Power, Adani Energy, Hero Future Energies, as it looks to expedite solar power capacity addition on railway land. Railway minister Piyush Goyal held a meeting with solar power companies Wednesday evening to explore possibilities of inviting wider private participation in solar tenders for Indian Railways. Power development will be on railway land, he said. "We are looking at rapidly increasing the number of solar tenders," a senior railway ministerial official told ET.

TikTok Chief Executive Kevin Mayer Resigns

San Francisco: Kevin Mayer, the chief executive of the Chinese-owned video app TikTok, resigned on Wednesday after his company came under sustained pressure from the Trump administration over its ties to China. Mayer, who joined TikTok in 2018, had been in the company for about a year. He was seen as a key figure in the company's efforts to expand in the US market. Mayer's resignation comes as the company faces scrutiny over its data practices and its relationship with the Chinese government. The company has been accused of spying for the Chinese government and of censoring content. Mayer's resignation is effective immediately.

Goyal Adds Byte to Land Bank Data

Launches one-stop repository to give info on plots, satellite view of terrain & heat maps on natural resources

New Delhi: In a move to make it easy for investors to identify sites for setting up manufacturing units, commerce and industry minister Piyush Goyal on Thursday launched a one-stop repository of the country's land bank comprising information on available and vacant plots, satellite view of terrain and heat maps on the natural resources there. Goyal also said the concept of deemed approval can be adopted in the upcoming one-stop digital platform to obtain all requisite central and state clearances required to start business operations in India. The National GIS-enabled Land Bank system, a database of industrial areas and clusters

across states, has information on more than 3,300 industrial parks across 31 states and UTs covering about 4.75 lakh hectare land. "Information available includes forest, drainage, raw material heat maps (agricultural, horticulture, mineral layers), multiple layers of connectivity", the commerce and industry minister said in a statement, adding that the project is launched for six states with others likely to be onboarded by December. The portal will also have information related to champion sectors and high priority sectors under "Make in India" such as state and district wise net industrial land available, relevant

PSU Banks Told to Keep Tab on Individual Bankruptcies

Move to ensure PSBs explore all avenues of realising their loans

New Delhi: The government has asked state-run banks to look out for insolvency cases that may also require proceedings to be initiated against personal guarantors of corporate debtors in the National Company Law Tribunal. This is to ensure that banks explore all avenues when realising loans. Rules empowering creditors to file insolvency applications against personal guarantors came into effect in December. "Banks may consider putting in place a mechanism for monitoring the cases which may require initiation of individual insolvency process before NCLT against personal guarantors to corporate



debtors," the department of financial services said in an advisory dated August 26. The department also asked banks to consider setting up an IT system to collate data regarding personal guarantors to corporate debtors in all such cases for requisite follow-up and "consequential action." The government suspended sections 7, 9 and 10 of the Insolvency & Bankruptcy Code for six months starting March 25 to prevent borrowers from being dragged into insolvency in the wake of Covid-19. Section 7 allows a financial creditor to initiate a corporate insolvency resolution process against a corporate debtor, section 9 provides for application of insolvency resolution proceedings by an operational creditor, and Section 10 is for initiation of insolvency resolution proceedings by a corporate applicant. The government will take a call at September end on whether the suspension needs to be extended. Experts said the government appears to be attempting to nudge lenders to invoke personal guarantors and initiate IBC proceedings against guarantors whenever possible.

Excessive Rain to Hit Crop Output

Pune: Persistent bursts of torrential rain, particularly in central and western India, are threatening crop output which is so far expected to rise to a new record and make agriculture the best performer in the Covid-hit economy. The southwest monsoon has turned vigorous in August after a deficient July, raising fears of floods. Rainfall this month has been 23% above normal in the country, with many parts of central and western India including Gujarat, Maharashtra and Madhya Pradesh receiving much more than average. The current spell of heavy rain has damaged urad and soyabean in central and western India. Excess rainfall may persist as the rain-boosting La Nina forecast is expected in the weeks ahead. "All talk of a massive crop of soybean and groundnut now

seems to be getting moderated with the rains showing no signs of relenting," said Atul Chaturvedi, president of trade body Solvent Extractors' Association, which expects 10-12% crop loss. Ratings agency Crisil says the possibility of excess rainfall due to La Nina is a risk factor for the forecast of summer-sown crop output rising 5%-6% to a new record. "But how the excess rainfall (if any) progresses would need to be monitored. An impact of La Nina on the kharif productivity and output will be dependent on various factors, such as time of occurrence, crop growth stage, spatial and temporal distribution of rainfall across states," said Crisil in an email response to ET.

25-29-Yr-Old Suffer Most Job Losses in April to July

New Delhi: Younger workforce in the age bracket 25-29 was hit the most during the April-July, witnessing the highest number of job losses and low fresh recruitments. The Centre for Monitoring Indian Economy said 121 million jobs were lost between April and July 2020, of which the highest 19.6 million were in the workforce of age less than 40 years. "Those in the age bracket 25-29 years account for 11% of all jobs, but they accounted for 46% of all job losses... Workers in the 20-24 years age group accounted for 35% of job losses till 2020 even when they account for less than 9% of total employment," CMIE said in its weekly analysis of the labour market. CMIE data shows although overall job losses declined in July, they increased among people from 25 through 34 years of age with 0.88 million job losses on a base of 88 million jobs.

"Enterprises are expanding less than earlier and therefore are generating lesser demand for additional labour which is usually met by youngsters who join the labour force," CMIE said. Terming the shift relatively older workers as "weird", it said this will have implications on future generations as India has a young population. As per the CMIE, the younger workforce in an enterprise is less experienced and therefore is more easily dispensable. "Moreover, during the lockdown enterprises cannot hire and train new recruits easily," it said.

Jio GenNext Pings Local Cos with 5G Tech; Offers Buyout, Funding

New Delhi: Reliance Jio GenNext, a startup accelerator of telecom operator Reliance Jio

Infocomm's parent Reliance Industries, has made buyout or investment proposals to a few domestic companies developing fifth-generation (5G) solutions as part of its attempt to launch a locally built next-generation network, said people aware of the matter. "Some of the domestic companies have recently received business proposals from Reliance Jio GenNext, which wants to acquire local firms developing 5G technology-based solutions,"

Another person said, "Jio is looking at Indian companies that are in the final stages to develop 5G components."
